PROJECT OVERVIEW:

The Centers for Medicare & Medicaid Services (CMS) contracted with Acumen, LLC, its non-profit partner firm The SPHERE Institute, and subcontractors (hereafter jointly referred to as “Acumen”) to develop outpatient outcome/efficiency measures. The contract name is Development, Reevaluation, and Implementation of Outpatient Outcome/Efficiency Measures. The contract number is 75FCMC18D0015, Task Order (TO) No. 75FCMC24F0146. As part of its measure re-specification process, Acumen convenes groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during measure development and maintenance. This TEP contributed direction and thoughtful input to re-specify the Breast Cancer Screening Recall Rate measure (OP-39) that is currently in use in the Hospital Outpatient Quality Reporting (Hospital OQR) program. This measure was submitted for Consensus-Based Entity (CBE) endorsement during the Fall 2023 cycle but did not receive endorsement. The purpose of this TEP is to re-specify the OP-39 measure in order to address the limitations and weaknesses discussed during the endorsement cycle.
