Development of Medicaid Total Cost of Care Measure

Project Overview:

The Centers for Medicare & Medicaid Services (CMS) contracted Yale New Haven Health Services Corporation – Center for Outcomes Research and Evaluation (CORE) to develop a Medicaid total cost of care (TCOC) measure for use initially in the CMS Innovation Center’s Innovation in Behavioral Health (IBH) Model. The contract name is Quality Measure Development and Analytic Support. The contract number is HHSM-75FCMC18D0042, Task Order HHSM-75FCMC24F0230. As part of its measure development process, CORE convenes groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during measure development and maintenance. The TEP will provide input and advice on the approach for measuring TCOC for services provided under the IBH Model to adult Medicaid beneficiaries with moderate to severe behavioral health conditions and substance use disorders (SUD).
