## **Project Overview:**

The Centers for Medicare & Medicaid Services (CMS) has *contracted with American Institutes for Research (AIR)* to develop *Patient Safety Measures of Hospital Harm for potential future use in CMS' quality and payment programs.* The *contract* name is *Measure & Instrument Development and Support (MIDS) Patient Safety Measure Development and Maintenance.* The *contract* number is *75FCMC18D0027.* As part of its measure development process, *AIR* convenes groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during measure development and maintenance. *The purpose of the TEP is to inform the development and maintenance of measures of hospital harm to improve patient safety and reduce or eliminate hospital-acquired conditions (HACs). The measures include:*

- *Hospital Harm – Severe Hypoglycemia*
- *Hospital Harm – Severe Hyperglycemia*
- *Hospital Harm – Opioid-Related Adverse Events*
- *Hospital Harm – Falls with Major Injury*
- *Hospital Harm – Acute Kidney Injury*
- *Hospital Harm – Pressure Injury*
- *Hospital Harm – Anticoagulant-Related Major Bleeding*
- *Hospital Harm – Postoperative Venous Thromboembolism*
- *Hospital Harm – Postoperative Respiratory Failure*
