Project Title: Development of Preventive Cancer Screening & Counseling Patient-Reported Outcome-based Performance Measure (PRO-PM)

Project Overview:

The Centers for Medicare & Medicaid Services (CMS) has contracted with Yale New Haven Health Services Corporation Center for Outcomes Research and Evaluation (YNHHSC/CORE) to develop a PRO-PM to assess preventive screenings for select cancers. The intent of the measure is to incentivize high-quality clinician counseling related to preventative cancer screening and to reduce disparities in screening for disadvantaged individuals and populations. The measure will apply to clinicians who are eligible to participate under the Merit-based Incentive Payment System (MIPS) and will use data collected from patients. The contract name is Development, Reevaluation, and Implementation of Outcome/Efficiency Measures, Option Period 2. The contract number is HHSM-75FCMC18D0042, Task Order Number HHSM-75FCMC19F0002.

As part of its measure development process, CORE convenes groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during measure development and maintenance. This TEP, comprising individuals with diverse perspectives and areas of expertise, will provide feedback inform development of the measure, including design of the patient survey instrument, data collection methodologies, and risk-adjustment approaches.
