Project Overview:

The Centers for Medicare & Medicaid Services (CMS) contracted with Mathematica to maintain two claims-based measures (Patient Safety Indicator [PSI] 90 composite and 30-Day Risk Standardized Death Rate among Surgical Inpatients with Complications [Failure-to-Rescue]).
