Project Title: CMS Quality Measure Development Plan/Quality Measure Index

Project Overview:

The Centers for Medicare & Medicaid Services (CMS) has contracted with Health Services Advisory Group, Inc. (HSAG) to develop and update the [CMS Quality Measure Development Plan](#) under the Measure & Instrument Development and Support IDIQ Contract #75FCMC18D0026, Impact Assessment of CMS Quality and Efficiency Measures Task Order #75FCMC19F0001. The CMS Quality Measure Development Plan (MDP) is mandated by the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA)¹ and serves as a strategic framework for clinician quality measure development to support the Merit-based Incentive Payment System (MIPS) and Advanced Alternative Payment Models (APMs), known collectively as the Quality Payment Program. The MDP was posted on the CMS.gov website in May 2016; [annual reports](#) chronicling progress made in advancing quality measures for the Quality Payment Program have been posted on the CMS website since 2017.

As a separate component of the Impact Assessment Task Order, HSAG is developing and refining the Quality Measure Index (QMI) as a decision support tool for measure selection, implementation, and continued use in CMS quality programs.

As required by its contract with CMS, HSAG convenes a group of stakeholders and experts to provide input on annual progress reports and update of the MDP required under MACRA, as well as the QMI project.
