## **Project Overview:**

The Centers for Medicare & Medicaid Services (CMS) has contracted with Yale New Haven Health Services Corporation – Center for Outcomes Research and Evaluation (CORE) to develop methodologies for measuring disparities in hospital outcome measures and additional measurement tools to promote equity in healthcare. The contract name is Development, Reevaluation, and Implementation of Outcome/Efficiency Measures for Hospital and Eligible Clinicians, Option Period 3. The contract number is HHSM-75FCMC18D0042, Task Order Number HHSM-75FCMC19F0001.
