## Project Title: Physician Cost Measures and Patient Relationship Codes (PCMP)

## **Project Overview:**

The Centers for Medicare & Medicaid Services (CMS) has contracted with Acumen, LLC to develop care episode and patient condition groups for use in risk-adjusted cost measures to meet the requirements of the *Medicare Access and CHIP Reauthorization Act of 2015 (MACRA)*. The contract name is "*Physician Cost Measures and Patient Relationship Codes (PCMP)*." The contract number is 75FCMC18D0015, Task Order 75FCMC19F0004. This project is a continuation of the work performed under the previous "*MACRA Episode Groups and Resource Use Measures*" contract (contract number HHSM-500-2013-13002I, Task Order HHSM-500-T0002). As part of its measure development process, Acumen convenes groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during measure development and maintenance. The project's overall objective is to develop and maintain population- and episode-based cost measures for use in in the Merit Based Incentive Payment System (MIPS) and the Hospital Value-based Purchasing (H-VBP) program. The objectives for the August 29 and 30, 2022 TEP meetings were to gather input on: (i) risk adjustment and health equity, (ii) priorities in comprehensive reevaluation, (iii) approaches to accounting for mortality, and (iv) measurement gaps and opportunities for high-value care.
