**Project Title:** *Addressing Social Needs (ASN) Electronic Clinical Quality Measure (eCQM)*

**Project Overview:**

The Centers for Medicare & Medicaid Services (CMS) contracted with Yale New Haven Health Services Corporation – Center for Outcomes Research and Evaluation (CORE) to re-design a measure of screening for social needs (e.g., housing status, food insecurity, transportation). The re-designed measure will be an electronic clinical quality measure (eCQM) evaluating hospitals addressing social needs. The contract name is Measure & Instrument Development and Support (MIDS): Development, Reevaluation, and Implementation of Outcome/Efficiency Measures for Hospital and Eligible Clinicians, Option Period 4. The contract number is HHSM-75FCMC18D0042. As part of its measure development process, CORE convenes groups of stakeholders and experts who contribute direction and thoughtful input to the measure developer during measure development and maintenance. The purpose of this TEP is to assemble a group with diverse perspectives and expertise to advise on conceptual, technical, and implementation considerations of this measure.
